Non-Registered Visiting Animals

Along with or instead of registered AAA/AAT teams, some facilities welcome visits from animal shelter volunteers, 4-H groups, dog clubs, family members, or friends who bring "non-registered" pets in to visit the residents. In some facilities, these may even be the most frequent animal visitors. Facilities permitting such visits may wish to post a notice similar to the following at the front entrance:





Attention visiting pet owners:

- ♦ All visiting pet owners/handlers must sign in using the pet registration book at the reception desk at the beginning and end of each visit. They are responsible for the pet's activities and behavior.
- All visiting dogs must be licensed and must wear an ID tag on collar or harness.
- ♦ All visiting animals must be clean and parasite-free.
- ♦ All dogs and cats must be on leash (or in a carrier) and under control at all times while in this facility.
- ♦ Please ask the receptionist for the visiting animal registration form, and owner statement, and fill these out if you have not already done so. Thank you for your cooperation.

The notice should contain some additional precautions if the facility has live-in animals:





Attention visiting pet owners:

- ♦ This facility has live-in companion animals roaming freely throughout the building!
- ♦ We would appreciate notification at least a few hours before your visit so that we can arrange for our live-in animals to be out of the way when you come.
- All visiting animals must be clean and parasite-free.
- ♦ All dogs and cats must be on leash (or in a carrier) and under control at all times while in this facility.
- ♦ Please ask the receptionist for the visiting animal registration form, and owner statement, and fill these out if you have not already done so. Thank you for your cooperation.
